[Rapid Bus Route Revamp to Enhance Services in Klang Valley](#)

Effective on January 16, 2026, Rapid Bus Sdn Bhd will restructure selected Klang Valley bus routes, with 16 Mass Rapid Transit feeder routes and 3 standard Rapid KL routes being fully converted to the Rapid KL On-Demand service in the first phase due to low daily passenger numbers.

A bill to facilitate border control arrangements for the Johor Bahru–Singapore RTS Link will be tabled in Parliament in February 2026, Transport Minister, Anthony Loke Siew Fook said. He noted that one of the Government's key steps is to introduce legislation to enable the co-location of Customs, Immigration and Quarantine facilities for the RTS Link, speaking on the sidelines of the **REHDA Institute CEO Series 2026** conference on January 15, 2026.
